5. If the dog control activity, or any part, has not been performed by the Kapiti Coast District Council during the last five calendar years, for example because it has been contracted out, performed pursuant to a Memorandum of Understanding or some other arrangement:

### a. The name of the party performing the work, the nature of the work being performed, and the period the work was performed by them.

Mains Security worked as a general contractor supplying various building security and after hour response from 1994 until July 2023, the description of animal control functions under the 2015 contract of work is provided below:

Main security currently run 4 patrol vehicles 24/7 these are easily sufficient in covering all public space and beach patrols. All vehicles are GPS tracked and report back to main monitoring if any event has occurred with resolution information.

Main security provides a dedicated 4WD to cover off all beach patrols the vehicle is dual branded with KCDC and main security.

#### After hours compliance complaints

Provide manpower as required by the Client to respond to compliance enquiries received between 17.00 hours in the evening and 8.00 hours the following morning 7 days a week.

Main security is manned 24/7 with fully trained personnel in all regulatory services and customer service. During the hours of 17:00 - 08:00 there are always a minimum of 2 internal staff on + on-call staff should the need arise. In addition the utilisation of, the on-road patrols to respond and report on compliance complaints.

#### **Out of Hours animal control**

Provision of out of hours, (early morning, evening, night time, weekend & public holiday), animal control services, consisting of the location, capture and detention of animals deemed to be causing a public nuisance or danger, care of such animals and reporting services back to the Client to enable owner or responsible person identification.

Main security has 18 trained animal control personnel with a minimum 5 during all required hours of control. In the event of a major event we have existing relationships with specialists contractors and emergency departments to call upon should the need arise. All incidents are reported and delivered the following morning.

In December 2023, when the contract was picked up by Eyes on Security, the role was subsequently reduced to the tasks outlined below. In June 2024 Eyes on Security was acquired by First Security who are contracted to carry out the work as described below.

Dog control is governed by the Dog Control Act 1996.

On 7 August 2017 Council's Senior Leadership Team (SLT) considered a service delivery overview of the Environmental Standards (Compliance) team which included animal management function. SLT resolved further to section 17A(3)(b) of the Act, the cost of conducting a review at this time would outweigh the benefits. This is attached.

Current dog control functions are carried out inhouse, with limited after-hours responses contracted to First Security as noted above. As such we are satisfied that the benefits of undertaking a review in relation to dog control matters under 17A of the Local Government Act 2002 do not justify the costs of undertaking the review.
