Thank you for your email of **7 February 2025** requesting the following information:

- 1. Is it possible to have the data for Waikanae and Waikanae Beach only from this survey please?***

The Kāpiti Community Alcohol Survey 2021 was a districtwide survey providing feedback from the community on the use and impacts of alcohol in the District, as well as views on the potential use of additional controls on alcohol sale and supply as part of any future policy. Analysis of the survey does not include results for underlying areas of the district.

The survey was intended to provide a broad snapshot across the district ahead of more detailed collection and analysis of impacts and attitudes to alcohol across the district and its underlying areas and communities. This work is to be progressed as part of work to develop a local alcohol policy, which is currently on hold pending the completion of the Health Strategy.

The location information in the data was not collated for the primary purpose of this survey and as such Council has an obligation under Privacy Principle 10 of the Privacy Act 2020 to not use it for any other purpose than the intended district-wide survey.
