ELECTRIC VEHICLE CHARGERS AND PARKING

PURPOSE OF REPORT

- 1 This report seeks the Waikanae Community Board's endorsement for the installation of an Electric Vehicle Fast Charger (50 kW DC) at Waikanae.
- 2 To promote the use of the Electric Vehicle Fast Charger the report also seeks endorsement for changes to current parking designations to 'Electric Vehicle Only' parking with a time restriction of P60.

DELEGATION

3 The Waikanae Community Board has the delegated authority to consider this matter under Part D of the Governance Structure and Delegations:

"Authority to approve or reject officer recommendations relating to **traffic control** and signage matters for existing local roads, except those matters that involve significant safety issues. Community Boards will be consulted about these matters but final delegation will rest with Council officers."

BACKGROUND

- 4 On January 31st 2017, the Waikanae Community Board approved the implementation of an EV-only and P120 parking restriction (including the installation of associated signage and ground marking) on the carpark next to a proposed EV charging point on Tutere Street as part of the 'Spark Plug' partnership. (report SP-17-097). The 'Spark Plug' partnership has since proved unfeasible and has been replaced by the trans-regional 'Horowhenua and Kāpiti Electric Roads' project.
- The 'Horowhenua and Kāpiti Electric Roads' project is a partnership between Electra, ChargeNet, Horowhenua Council and Kāpiti Coast District Council, with funding from the Energy Efficiency Conservation Authority's (EECA) Low Emission Vehicle Contestable Fund (LEVCF) to install nine EV Fast Chargers in five strategic locations in Kāpiti and Horowhenua.
- The project aims to support a transition to low emission transport options by strengthening the nationwide recharging network and encouraging the uptake of Electric Vehicles (EVs) within Horowhenua and Kāpiti districts. It supports business, private drivers and passengers of EV's to easily reach destinations in Horowhenua and Kāpiti. (see Appendix 1 for more details of this project and partnership).

- 7 Five fast chargers are to be installed in communities around Kāpiti, the proposed sites are:
 - Paekākāriki
 - Raumati Beach
 - Paraparaumu Coastlands (x2)
 - Waikanae or Waikanae Beach

ISSUES AND OPTIONS

Issues

Waikanae Beach EV Fast Charger

- A 50kW DC Fast Tritium Veefil EV Charger is substantially faster and easier to use than the previous planned 'Spark Plug' charger. It offers conveniently short charging times an 80% battery charge can be achieved in 20-60mins depending on the make and model of electric vehicle. The 50kW DC model does not require EV drivers to supply their own charging cord.
- The site for a fast charger requires an adequate power supply, lighting and perpendicular parks to be safely accessible to all EV's (some vehicle models have the charger at the back of the car and need to reverse into the park). A location that is close to local businesses and amenities benefits both EV drivers and local businesses.
- 10 A P60 'EV only' parking restriction is recommended to enable optimum use of the charger. Two designated P60 'EV only' parks are recommended so that when the charger is in use another EV driver can 'queue' to use it.
- 11 Two sites have been assessed as suitable locations to install an EV charger Tutere St in Waikanae Beach and the Waikanae Park and Ride in Waikanae.
- 12 Waikanae residents and EV drivers have been surveyed to offer their feedback on these two sites. On 19th Sept the survey results showed:
 - 56% preferred the Tutere St site
 - 44% preferred the Waikanae Park and Ride.
- 13 The project is due to be completed by April 2019, see Appendix 1 for more timeline detail.

Options

14 This report proposes two options for an EV charger site in Waikanae.

Option 1

Tutere St, Waikanae Beach

15 For an EV fast charger the parking layout needs to be changed from an angle park to a perpendicular (or right angle) one to support the infrastructure requirements of the Charger. This will result in the reduction of one car park from the current carparks available.

- 16 Recommended parking restrictions for this option is 'P60', 'EV only' for one or two parks (the second park enables drivers to queue for the charger).
 - Survey results: 56% of responses prefer this site
 - Feedback on the survey noted a preference for this site because it is closer to the highway and referred to as a nice place to visit especially with its cafes and playground - 'the beach has more of a "have a stroll and grab a coffee feel".
- 17 This is the preferred option as it supports the survey results undertaken by Waikanae residents in September.

Option 2

Waikanae Park and Ride

- 18 This site at Waikanae Park and Ride already has an EV charging station but it is not a fast charger. EV only parking is already in place and no changes to parking layout or parking restrictions are required.
 - Survey results: 44% of responses prefer this site.
 - Feedback on the survey noted a preference because the parks existed already, being near a supermarket appealed and that Waikanae businesses could benefit from the exposure. Other comments indicated concerns the parks would be used by non EV drivers and that it was too far away from the highway.

CONSIDERATIONS

Legal considerations

- 19 The Council's legal Counsel have confirmed that there are no legal considerations.
- 20 The signage and road-marking used are in accordance with New Zealand Transport Agency (NZTA) guidelines. NZTA have gazetted standard symbols for EV charging and parking and these will be used.

Financial considerations

- 21 The 50kW DC charger infrastructure, installation, subsequent signage and road marking costs are covered by the 'Horowhenua and Kāpiti Electric Roads' partnership.
- 22 The Council's \$40,000 contribution to the 'Horowhenua and Kāpiti Electric Roads' partnership has been allocated from Strategy and Planning. There are sufficient funds to support this initiative within the Environmental Sustainability budget.

Tāngata whenua considerations

23 There are no known issues relating to iwi or the Treaty of Waitangi.

SIGNIFICANCE AND ENGAGEMENT

Consultation already undertaken

- 24 An email informing Council's intention to submit a proposal to the EECA Low Emission Vehicle Contestable Fund was sent to all Community Board members on March 19th 2018.
- 25 An initial announcement of successful Low Emission Vehicle Funding (LEVF) applications was announced by EECA on August 7th. Following this announcement, a notice was put out in the Elected Members Bulletin available to community board members.
- 26 A presentation about the project and options for sites was given to the Waikanae Community Board on August 11th. A subsequent survey was developed to ask the public which site they preferred.
- 27 Waikanae residents were surveyed from Sept 12 20th.
- 28 Once the chargers are in place further publicity will occur through the Council's media channels to promote their placement and uptake.

RECOMMENDATIONS

- 29 That the Waikanae Community Board endorses the installation of an Electric charger in Waikanae and:
 - 29.1 Agrees to recommend to Council that Tutere Street, Waikanae Beach location is the preferred site for the EV Charger installation.
 - 29.2 Recommends to Council to change the parking designation of one carpark to P60 'EV only' parks, to promote use of the Charging station.

- b. charging units and associated gear delivered on site and installed (civil works and electrical works)
- c. electrical testing, inspection, and livened
- d. location added to Charge Net NZ billing network and public maps

Subsequent 90 days (February – April 2019)

- a. promotion and public launch of sites (Facebook and local newspaper media release)
- b. contingency for installation in case of unforeseen delays






Signage and charger






