As per the process for someone objecting the classification of their dog, I have attached all correspondence in relation to the incident.

Process captured below on next steps.

- 18. Upon receiving a written objection to a menacing or dangerous classification, the AMTL forwards a copy of the objection along with all supporting documentation to the ESM.
- 19. The ESM notifies the Group Manager (GM) that there will be an objection going to the AHC.
- 20. The ESM provides copies of information to Council's legal team for review of initial decision before proceeding to committee hearing.
- 21. The AMTL contacts Democracy Services to schedule a meeting of the AHC and prepares a report.
- 22. The AMTL notifies dog owner of time, date, and location of meeting.
