Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **14 June 2024** requesting the following information:

- All projects and council work carried out over \$50k at Waikanae Beach and Peka Peka Beach areas over the 2023 to 2024 FY to date excluding stormwater projects, their location, cost and date.***

The Council's Parks, Open Space, and Environment teams carried out the replacement of the Victor Weggery Drive playground in the 2023/2024 financial year. The project commenced November 2023 and was completed in March 2024 at a total cost of \$261,189.

The Council Property Team are upgrading the existing Waikanae Beach public toilets at the Waikanae Boating Club in a new location with a new 5 stall toilet facility. The total value will be \$568,950.00 + GST. Installation is expected to be completed by mid-September 2024.
